# **Collection Information:**

#### **Scope and Content Note**

The Connersville First Presbyterian Church Records includes materials relating to the founding, management, and day-to-day activities of the church along with its members and community, dated 1824-2012. The collection contains session and other committee minutes, financial records, registers, newspaper clippings, church historical documents, correspondence, bibles, books, photographs, and pamphlets. Topics discussed throughout the collection include God, church history, the founding of the church, the split of the church, the reunification of the church, finances, maintenance, and repairs to buildings, building expansion, genealogical and family history information, Presbyterian history, Presbyterian views, and community outreach and impact.

#### **Historical Information**

Connersville First Presbyterian Church was originally organized in Connersville, Fayette County, IN on October 3, 1824, by Rev. Daniel Hayden. The first church building was constructed in 1833 between Fifth and Sixth Streets. The congregation moved to a new building in 1845 on West Fourth Street. In 1851, a group withdrew (a "New School" movement) and organized the Constitutional Presbyterian Church of Connersville (Second Presbyterian Church of Connersville). The new church built a building on the corner of Seventh and Central Streets in 1855. On November 11, 1870, the First Presbyterian Church of Connersville and the Constitutional Presbyterian Church merged back into one church, the First Presbyterian Church of Connersville. As a congregation, they elected all new leaders, excluding trustees, and decided to use the building on the corner of Seventh and Central Streets. Through the years, additions were added onto

the church including rooms, stained glass windows, and normal maintenance and repairs. The church is still active today.

## Organization

The Connersville First Presbyterian Church Collection is organized by Session Minutes, Financial Records, Church Registers, Committee Minutes, Newspaper Clippings, Church History, Correspondence, Books, Miscellaneous – Photos, and Miscellaneous – Documents & Pamphlets.
